

1. **Mayadevi Rural Municipality** invites electronic sealed quotations from Nepalese eligible bidders for the **Construction of various projects at the Mayadevi Rural Municipality Rupandehi under National Sealed Quotation Bidding procedures.**
2. Eligible Bidders may obtain further information at the office of **Mayadevi Rural Municipality, Rupandehi**, and inspect the Bidding Documents may visit PPMO website www.bolpatra.gov.np/egp.
3. Bidder who chooses to submit their bid electronically download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document fee Nrs. 1000 (non-Refundable) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Electronic bids must be submitted to the office **Mayadevi Rural Municipality, Rupandehi**, by through PPMO website www.bolpatra.gov.np/egp on or before **12:00 Noon** on **19th May 2023**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM and Date 19th May 2023** at the office of **Mayadevi Rural Municipality, Rupandehi**. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of as specified in table below, which shall be valid for 30 days beyond the validity period of the bid i.e., **75 Days**.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
